Caryl Terrell — Winner of the Liesl Blockstein Community Leadership Award

The Sierra Club Foundation, John Muir Chapter, nominated Caryl for her 40-year career on behalf of environmental protection.

I see lots of friends and acquaintances and peers here tonight who do as much as I do or more—so receiving this award is very humbling. We are all passionate about our causes, we're all dedicated, and we're all enthusiastic about our work. We all take heart from Margaret Mead's quote: "Never doubt that a small group of thoughtful, committed citizens can change the world. Indeed, it is the only thing that ever has."

Among those committed citizens I should thank is my husband Bob, who likes to say that whenever someone asks me to do something, instead of saying "no" I say "no problem." Barbara Munson — Winner of the Sally Sunde Family Advocate Award

The Wisconsin Network for Peace and Justice nominated Barbara for her work as an artist-educator, an arts advocate, and her leadership on Act 250, recently signed into law.

As an artist, and a supporter of the art of storytelling, I'll share a story with you about this legislation—Act 250, the Race-Based “Indian” Nicknames, Logos, and Mascots Law. It took 17 years of hard work by the Wisconsin Indian Education Association (WIEA).

Along the way we had marvelous allies. While we native people led this struggle, we've been helped by an amazing coalition of citizens. Among them are the two champions who sponsored the bill: Rep. Jim Soletski, who is here tonight, and Sen. Spencer Coggs. They deserve a great deal of thanks for

what they did in getting this bill passed. With all of us working together, it clearly shows the best spirit of Wisconsin in action.

I also want to thank my husband Robert, the love of my life. I thank my daughter Chris—whose complaint about her school logo nearly 20 years ago was what led me into advocacy on this issue. And I thank my granddaughter Rio who's my inspiration because, in the end, the work we do is for the young. As we say in the Oneida Thanksgiving address, “We give thanks to our Grandmother the Moon, we work hand in hand with her, for the future faces that are coming.”

Erin O'Brien — Winner of the Linda Sundberg Civil Rights Defender Award

Wisconsin Wetlands Association nominated Erin for her work in helping concerned citizens raise their voices to help preserve our state's wetlands.

One of our mantras at Wisconsin Wetlands is: no matter who you are or where you live, wetlands affect your life. Wetlands make our water cleaner, whether we're talking about drinking water or places to fish and swim. Wetlands provide habitat for plants and animals—many of them endangered—and protect us from floods. We work hard to enable individuals, organizations, and community leaders to protect these wetland functions which, in turn, will improve their own communities.

I like to think that Linda Sundberg, for whom this award is named, would embrace a conservation group being named a Civil Rights Defender. Clean drinking water, protection from floods, and the ability to swim in or fish from healthy waters are basic human rights. And participating in decisions affecting these resources is a civil right . . . in the same way that any democratic process is a civil right.

Because wetlands store and slowly release rain and snowmelt, you only need to look as far back as the 2008 floods to see how loss of wetlands affects communities—and conversely how their preservation can improve our communities. For me and for many other people, wetlands are a quality of life issue and a justice issue. Our environment doesn't have a voice unless we provide one.

What's your philosophy on giving?

“What you give comes back to you 100-fold.” That's what my grandmother, Mary Pickford Rogers, used to say about donating either time or money, and it's still one of the reasons I give to nonprofits today.

I look back on so many things—people who've helped me and given me their time, or people who've helped my friends or family. My work with CSW is one way I repay that generosity.

Why give to CSW in particular?

CSW's commitment to social justice nonprofits and advocacy nonprofits is really important. Many people like to give to direct-service organizations. But advocacy and social justice work is also critical since it focuses on the larger picture. By helping to change the framework, these groups can prevent social problems from occurring.

My belief is that as advocacy and social justice work addresses the root causes of today's serious social ills, we may someday see that direct-service groups have an opportunity to change their focus.

I know that CSW is a good steward of the funds it receives. And I've seen how Community Shares' nonprofits and volunteers make a difference in both small and significant ways. After all, we make progress one positive change at a time!
